FAIR HOUSING 101: Fair Housing Basics

¼-day class for up to 15 people / Fee \$400*

Introduction and overview of federal, state, and local fair housing laws. In-depth discussion of the application of fair housing law for families with children and people with disabilities—two areas the FHCO receives the greatest complaints. Issues covered include:

- protected classes and discriminatory actions
- who must comply with the law
- how the law is enforced

FAIR HOUSING 150: Advanced Fair Housing

½-day class for up to 15 people / Fee \$550*

Fair housing overview followed by small group discussion and scenario analysis or other activities focused on issues concerning reasonable accommodation and modification, domestic violence situations, families with children, and / or tenant-on-tenant harassment. Q&A encouraged.

FAIR HOUSING 200: Advanced Jeopardy Game

¼-day class for up to 15 people / Fee \$400*

Put on your thinking caps and competitive spirit for this fun opportunity to test your fair housing knowledge and win prizes. This session is ideal for groups that have already had basic fair housing training. Jeopardy categories include protected classes, random acts of discrimination, modifications & accommodations, and testing. Game is followed by question and answer session and legal updates.

***NOTE:** Unless otherwise stated, class fees are based on length of class and the size of the audience; the base cost assumes 15 or few attendees with an additional cost per person beyond that. Travel expenses are calculated in addition to the cost of the class.

Q: Do You Ever Offer Free Classes?

There are times presentations may be covered under a pre-existing grant, allowing for reduced training costs; please inquire. Unfortunately, these resources are limited in proportion to the number of training requests we receive each year.

Q: Do FHCO Classes Include Continuing Education certificates?

Yes. FHCO has been a Certified Continuing Education (CE) Provider authorized to provide continuing education to Oregon real estate licensees for credit since 10/2010. Unfortunately, CEs are not available for Washington state licensees however general certificates of attendance are available upon request for any FHCO class.

Q: Are there other training options besides a private class?

Yes. FHCO staff routinely conducts classes for Metro Multifamily Housing Assn. (http://metromultifamily.com/calendar_list.asp) and Oregon Affordable Housing Management Assn. (<http://oregonaffordablehousingmanagement.com/continuingeducation.htm>).

These classes are designed for each association's members but are open to non-members as well. Visit each association's website for upcoming classes and pricing information.

Preregistration is required and should be done through the hosting association directly. Q: Do you offer classes appropriate to corporate audiences?

Yes. The Historical Edition of FHCO's very popular "Fair Housing Jeopardy" class was created for the corporate environment. It uses housing as a convenient backdrop for exploring the historical roots of discrimination and segregation that continues to influence our lives today. Where we live has so much to do with how we live, who we live next to, where our children go to school, where we work, what services are available to us, what our transportation options are, etc.

This program offers a unique opportunity to explore the historical context of issues of equality and diversity that we face today in an entertaining and safe environment. The discussions that ensue can be transformative and the experience can make for exceptional team building and diversity awareness experiences. For details contact FHCO's Education Dept.

Q: Are there other training options besides a private class?

Yes. FHCO offers a dynamic and moving historic tour of housing discrimination that includes a guided bus tour and an exploration of the area's hidden history of discrimination. The stops made and stories told will depend on the area toured but most include the ghosts of lost ethnic communities, the prominence of the KKK, reference to historical state laws that were blatantly racist, recent case law and more.

Whenever possible, tours also feature on-site presentations by local experts who experienced pivotal moments in the community's history. We recommend the tour be followed by group discussions, a panel presentation, or other activities before a closing statement about fair housing trends and current day challenges.
